AN ORDINANCE FIXING RATES AND CHARGES FOR WATER FURNISHED BY TH WATERWORKS SYSTEM AND AMENDING THE VILLAGE OF CHATAM CODE OF ORDINANCES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Section 51.018 (A) (1) of the Code of Ordinances of the Village of Chatham is amended to state as follows":

(A) (1) The following shall be the rates for water supplies through the waterworks system of the Village of Chatham, payable monthly within 15 days after rendition of each bill.
