SUBJECT: Recommendation to Contract for Well Data Collection

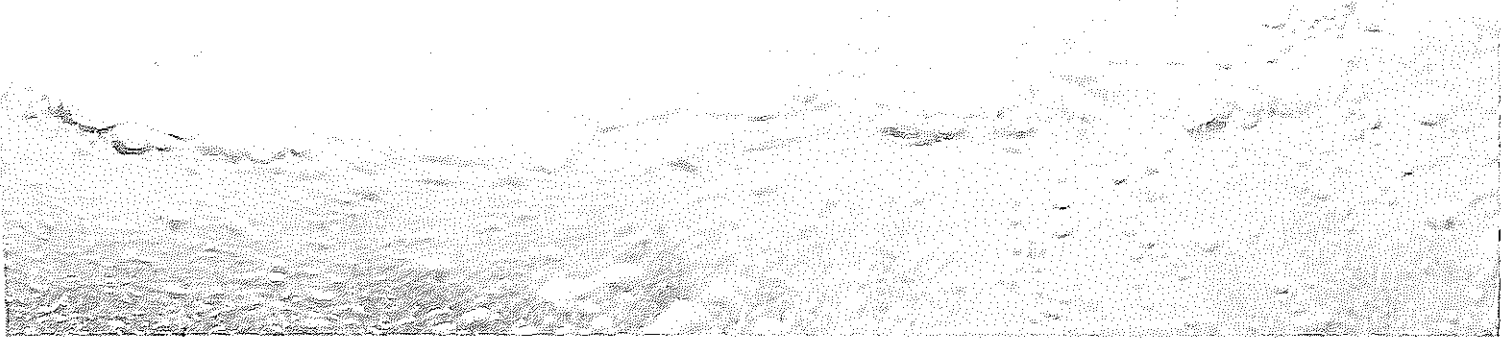
Dear Mr. McCord:

As Project Manager, as Agent for the Village of Chatham for the Village Water Project EMC recommends that the Village of Chatham purchase investigatory services and data collection from Water Well Solutions, Drilling Division, LLC to confirm the suitability of the proposed well field for the proposed water system.

The Design and Engineering team lead by EMC, consisting of Donohue and Associates, Inc and Greene & Bradford, Inc solicited proposals for the provision of test hole and test well services from a number of reputable firms. The team received and analyzed responses from two of the solicited firms. Of these two firms one is willing to meet the criteria of the investigation and has the available resources to mobilize to the site and perform the services within the schedule requirements of the project. Additionally, the firm with the available personnel and equipment provided the lower of the two price proposals for the qualifying scope of work.

We recommend that the Village of Chatham purchase the following services:

- Mobilize workers and equipment to site \$3,500.00
- Drill monitoring holes and split spoon sample (3 wells per test hole suggested)
Estimate 360 LF @ \$20.75 / LF \$7,470.00
- Complete monitoring holes with 2" PVC casing and 10'-0" PVC well Screen
Estimate 360 LF @ \$9.00 / LF \$3,240.00
- Construct 2 - 6" PVC test wells with 20'-0" of .010" PVC well screen
Lump Sum 2 @ \$5,392.50 ea (60'-0" depth basis) \$10,785.00
- Install and remove test pumping equipment capable of 400 GPM in test wells
Lump Sum 2 @ \$2,000.00 ea \$4,000.00

AN ORDINANCE ACCEPTING A BID FOR INVESTIGATORY SERVICES AND DATA COLLECTION ON WELL FIELD

WHEREAS, the Village advertised and obtained quotes for Drilling Test Wells for potential well sites; and

SECTION 2: The Director of Administration and Utilities is hereby directed to complete the necessary documents at the appropriate timing.

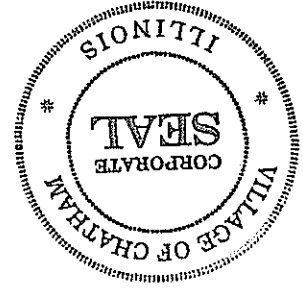
SECTION 3: This Ordinance is effective upon its passage and approval.
