FIRST AMENDMENT TO AGREEMENT FOR PRIVATE REDEVELOPMENT BETWEEN THE VILLAGE OF CHATHAM AND BROTHERS AND WIVES, LLC

This is the first amendment to that certain Agreement For Private Redevelopment Between The Village Of Chatham And Brothers And Wives, LLC dated July 6, 2007 and approved by Ordinance No. 06-350f the Village of Chatham (the "Agreement").

Paragraph 25 of the Agreement is amended to state as follows:

25. As set forth in Exhibit A, Redeveloper anticipates the sum of \$11,200 in architectural and engineering fees for the project. Notwithstanding any other provision in this Agreement to the contrary, the Village agrees to reimburse a portion of those fees on or before $\underline{December \ 15}$, 2007, not to exceed \$11,200, upon presentation by Redeveloper of a reimbursement application accompanied by with evidence of payment of such professional fees. (the "Advance Payment"). The Advance Payment shall be deducted by the Village from the first several payments of Tax Increment to Redeveloper under this Agreement until the Advance Payment has been deducted in full. No payments of Tax Increment shall be made to Redeveloper until the Advance Payments have been deducted in full.

If the project contemplated by this Agreement is not completed by December 15, 2007, Redeveloper shall repay the Advance Payment to the Village within 30 days of written demand by the Village. Redeveloper's obligation of repayment has been personally guaranteed by an officer of Redeveloper, Jaime Loftus.

Redeveloper may not assign this Agreement until the Advance Payment has been deducted or repaid in full.
