
*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** The corporate authorities of the Village of Chatham deem it necessary, appropriate and in the public interest for the Village of Chatham to proceed with the final design and financing of the Village of Chatham water treatment plant, well field, and transmission line.


**SECTION 2:** The proper officers of the Village are authorized and directed to direct the Village's engineers and consultants, including but not limited to EMC, Inc., Donohue & Associates, Greene & Bradford, Inc., Michael Williamsen, P.E., and Hart, Southworth & Witsman, attorneys, to proceed with the final design and bidding of the project, and to secure financing for the project.

**SECTION 3:** This Ordinance is effective upon its passage and publication as required by law. The Clerk shall publish this ordinance in pamphlet form.

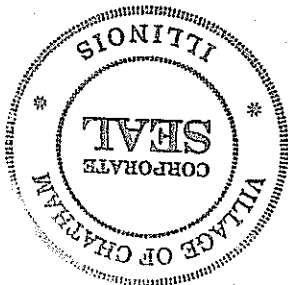
