## AN ORDINANCE AUTHORIZING AND DIRECTING THE VILLAGE PRESIDENT TO TERMINATE THE WATER SUPPLY CONTRACT WITH THE CITY OF SPRINGFIELD, ILLINOIS

WHEREAS, the Village of Chatham entered into a water supply contract with the City of Springfield in 1967;

WHEREAS, the Contract has been amended in 1970, 1993, and 1998, and pursuant to such amendments, the contract expires on December 31, 2013, unless the Village develops an alternative source of supply and gives the City of Springfield three years' prior notice of termination of the contract;

WHEREAS, the Village has for at least the past five years been engaged in the design of an alternative source of supply, specifically, a new water treatment plant, well field and transmission line, and has identified sources of financing for such alternative source of supply;

WHEREAS, by Ordinance of even date herewith, the Village has determined to proceed with the final design and financing of the alternative source of supply;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1**: Within thirty days hereof, the Village President is authorized and directed to notify the City of Springfield that the 1967 water contract, as amended, is terminated effective three years from the date of the notice.

**SECTION 2**: This Ordinance is effective upon its passage and publication

as required by law. The Clerk shall publish this ordinance in pamphlet form.
