WHEREAS, the Village advertised and obtained bids for the replacement of the twelve inch water main on Walnut Street from the west end of Willow Glen Subdivision to Park Avenue, approximately 2900 feet, with 1500 feet an eighteen inch and 1400 feet of twelve inch; with the existing twelve and six inch main to be abandoned; and

WHEREAS, the Public Works Committee met to review the bids and is recommending the lowest bid from HD Supply Water Works for \$79,487.61.
