BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE
OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That the Regular Village Board Meetings of the Village of Chatham for Calendar
Year 2008 shall be held at 6:30 PM at the Village Hall, 117 East Mulberry Street, Chatham,
Illinois on the second (2nd) and fourth (4th) Tuesday of every month, except in December when it


