ORDINANCE NO. 08- 19

*AN ORDINANCE PERTAINING TO POLICE OFFICER SALARIES*

**WHEREAS**, the President and Board of Trustees of the Village of Chatham have determined that it is in the best interest of the Village to maintain a well trained, professional police force; and

**WHEREAS**, the Village Board has determined that pay for police officers who serve the Village must be commensurate with surrounding and competing departments to assist in providing a stable force of trained officers.

**WHEREAS**, the Administrative Committee is recommending the following salary schedule for Officers of the Village of Chatham Police Department.

***NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS AS FOLLOWS:***
