

Ordinance No. 09- 10

**AN ORDINANCE AMENDING CERTAIN PROVISIONS IN THE ZONING  
CHAPTER OF THE VILLAGE OF CHATHAM CODE OF ORDINANCES  
PERTAINING TO OFF STREET PARKING**

WHEREAS, the corporate authorities of the Village of Chatham have proposed an amendment to the Zoning Chapter of the Code of Ordinances of the Village of Chatham pertaining to the use of parking facilities;

WHEREAS, after public notice in the Chatham Clarion and a public hearing conducted on 3/19/02, the Planning Commission considered the proposed change to the zoning ordinance and recommended approval thereof, with amendments, to the Village Board;

WHEREAS, the Public Works Committee of the Village Board has recommended further amendments to the language as recommended by the Planning Commission;

*NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** Section 158.072(L)(2) of the Code of Ordinances of the Village of Chatham, relating off-street parking, is amended by the addition of subsections d, e and f, to state as follows:

d. Motor homes, trailers, and campers parked in residential districts shall be operable and shall have a current Illinois vehicle license. Boats shall be operable and have a current boat license.

e. Motor homes, trailers, campers and boats parked in residential districts shall not be used for the storage of goods, materials or equipment other than those items which are part of the unit or essential for

its immediate use.

f. Motor homes, trailers, campers and boats parked in residential districts shall be kept locked or otherwise secured when not in use.

**SECTION 2:** This ordinance is effective upon its passage, approval and publication as required by law. The Clerk shall publish this ordinance in pamphlet form and see to its inclusion in the next update of the Village of Chatham Code of Ordinances.
