Ordinance No. 10 - 04

AN ORDINANCE ANNEXING BALL-CHATHAM COMMUNITY SCHOOL DISTRICT #5 PROPERTY ON GORDON DRIVE

WHEREAS, on December 22, 2009 a Petition for Annexation pursuant to Section 7-1-8 of the Illinois Municipal Code was filed by Ball-Chatham Community Unit School District #5 with the corporate authorities of the Village of Chatham, Illinois;

WHEREAS, the property sought to be annexed is legally described and shown in a Plat of Annexation attached to this Ordinance as Exhibits A;

WHEREAS, the Petition for Annexation states that the Petitioner comprises all of the owners of record of the land sought to be annexed and that the Petitioner comprises at least 51% of the electors in said territory.

WHEREAS, the land sought to be annexed is within Ball Township and the prescribed notifications have been accomplished;

WHEREAS, the Village of Chatham does not provide fire protection or a public library, such that the Trustees of the Chatham Fire Protection District and Chatham Public Library District need not be served with notice;

WHEREAS, the corporate authorities of the Village of

Chatham find it to be in the best interest of the Village of Chatham to annex the territory.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The territory, legally described as follows:

The Northwest Quarter of the Southeast Quarter, lying east of the railroad right-of-way; the Southeast Quarter of the Northeast Quarter; and all that part of the West Half of the Northeast Quarter lying east of the railroad right-of-way; all in Section Six (6), Township Fourteen (14) North, Range Five (5) West of the Third Principal Meridian, Sangamon County, Illinois (tax i.d. #29-06-200-006); and all that part of the Northeast Quarter of the Southwest Quarter of Section (6), Township Fourteen (14) North, Range Five (5) West of the Third Principal Meridian lying east of the railroad right-of-way (tax id #29-06- 300-048) is hereby annexed to the Village of Chatham, together with public roadways within such property or adjacent thereto.

SECTION 2: This ordinance is effective immediately.

SECTION 3: The Village Clerk shall forthwith cause this Ordinance to be recorded with the Recorder of Deeds of Sangamon County and with the County Clerk of Sangamon County.


