INTERGOVERNMENTAL AGREEMENT

This Agreement is between the Village of Chatham, an Illinois municipal corporation, ("Village"), and the Ball-Chatham Community Unit District # 5, ("District"), and relates to the construction of a new elementary school on property owned by the District on Gordon Drive and depicted on Exhibit A hereto (the "School Site").

The parties agree as follows:

1. The Village shall, at its cost or at the cost of a third party, but in any event without cost to the District, extend or provide for the extension of Acacia Lane to the School Site in accordance with specifications established by the parties. The road will be sufficient for construction traffic to and from the site of the elementary school, and be constructed in advance of the District's commencement of construction of the elementary school, which as of the date of this agreement, is estimated to be ______, 2010.

2. The parties agree that a six-inch water main loop is necessary and appropriate to serve the School Site. The District shall at its cost design the water main loop for installation at locations to be agreed by the parties, and shall provide all pipe, connections, and other materials necessary to construct the water main loop. The Village shall perform the installation of the water main loop at its cost in conjunction with the construction of the elementary school and after consultation with the District and shall thereafter be responsible for maintenance and repair of such water main loop. The District shall dedicate the main to the Village upon its completion, together with all easements necessary for future access to and maintenance of the water main.

3. The District shall provide and install an electric transformer pad located near the southwest side of the elementary school. The Village shall purchase and install a transformer, the size and characteristics of which will be agreed by the parties, on the pad, and shall provide and install a primary line from Plummer Boulevard to the transformer, in conjunction with the construction of the elementary school and after consultation with the District and shall thereafter be responsible for maintenance and repair of such equipment and line. The District shall dedicate the electric primary line and the transformer to the Village upon their completion, together with all easements necessary for future access to and maintenance of the line and transformer.

4. This is the entire Agreement between the parties with respect to its subject matter. All oral representations regarding this Agreement prior to the date hereof are expressly disclaimed. This Agreement is effective upon approval by the corporate authorities of the parties and its execution by authorized officers of the parties. All modifications to this Agreement shall be in writings executed by the chief executive officers of the parties and approved by ordinance or resolution. This Agreement shall be governed in accordance with Illinois law.


