**AN ORDINANCE FIXING RATES AND CHARGES FOR SEWER SERVICE
FURNISHED BY THE SEWER/WATERWORKS SYSTEM AND AMENDING
THE VILLAGE OF CHATHAM CODE OF ORDINANCES**

*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

SECTION 1: Section 51.106 (A) of the Code of Ordinances of the Village of Chatham is amended to state as follows:


(A) (1) The rates shall be and are based upon the amount of water provided by the water workers system of the village. A minimum charge of \$10.18 per month shall be applied to all users whose water consumption does not exceed 3000 gallons per month s measured by the water meter for the user facility.

(A)(2) The following shall be the rates to users consuming water supplies through the waterworks system of the Village of Chatham, payable monthly within 15 days after rendition of each bill.


| <u>Volume</u> | <u>Rate</u> |
|-----------------------|----------------------|
| 0 - 3,000 gal/month | \$ 10.18 |
| 3001 - 6000 gal/month | \$ 3.41 per 1000 gal |
| Over 6000 gal/month | \$ 1.32 per 1000 gal |

SECTION 4: This Ordinance shall take effect with respect to bills due on or after June 1, 2010. The Clerk shall forthwith publish this Ordinance in pamphlet form, and shall see to its inclusion in the next annual update of the Village of Chatham Code of Ordinances.


