Ordinance No. 10-

AN ORDINANCE FURTHER AMENDING APPENDIX B TO CHAPTER 150 OF THE VILLAGE OF CHATHAM CODE OF ORDINANCES PERTAINING TO BUILDING INSPECTION FEES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Subsections B through F of Appendix B to Chapter 150 of the Code of Ordinances of the Village of Chatham is amended to state as follows (amended language struck out, new language underlined):

(B) Mechanical permit fee. \$40.00 \$70.00

(C) Electrical permit fee. \$40.00 \$70.00

(D) Plumbing permit fee. \$50.00-\$70.00

- (E) Plan review fee. If conducted for the village by IRC or consultants \$150 deposit required; balance to be bulled to owner at cost plus 5% administration fee, to be paid before final inspection. If conducted by the Building Code Administrator, no additional charge.
- (F) Re-inspection fee. If a structure or other work fails an inspection, necessitating a re- inspection, the re-inspection fee shall be \$40 for any re-inspection other that plumbing, and \$50 for a plumbing re-inspection, whichever is greater. \$70.00.

SECTION 2: This ordinance is effective upon its passage, approval and publication as required by law. The Clerk shall publish this ordinance in pamphlet form and see to its inclusion in the next update of the Village of Chatham Code of Ordinances.
