Pat -

Hanson is willing to provide the Village of Chatham with a RTK GPS unit and instruct your qualified designee on the basics of how and where to use the equipment. Along with this rental, we would include technical support with the fee for using our equipment. Hanson can offer the following RTK GPS units to the Village of Chatham for rental:

Option 1) 5700 RTK Rover system with TSC1- \$1,500 per month / \$15,000 per year

This is the older and slower of the systems we could offer for your use. The attached photo shows approximately what it looks like. We would provide the Zephyr antenna, range pole (fixed height 2m), a TSC1 controller (TSCe shown in photo), Trimble 5700 Receiver, receive-only radio (on the pole) and cords and batteries. No backpack is needed and would not be included.

This unit could receive corrections via radio signal from the Sangamon County Base Station whereas no additional units or mobile phone service is required. This unit does not receive signals from GNSS (Russian equivalent of GPS) satellites, so there will be short periods of time when satellite coverage is more sparse than others (slower).

Option 2) R8 GNSS rover system with TSC2 - \$3,500 per month / \$35,000 per year

This is a newer system which can receive correction from the Sangamon County Base (like Option # 1) or from the Trimble VRS Now network (upgraded correction signal) using a data modem. The attached photo shows that with this unit, the GPS receiver is combined with the antenna and radio such that the system is much lighter.

This system will operate faster than Option 1 and will be much less likely to encounter lapses in satellite coverage as it receives additional signal from the GNSS (Russian satellite constellation). This unit is also slightly more accurate when incorporating the data from the Russian satellites. This unit uses Bluetooth signal to communicate and there are no cords to mess with. We would provide the VRS data service (\$2500 yearly subscription) and mobile data phone and service with this unit.

Another option would be for the Village of Chatham to purchase its own RTK GPS rover system for this work. You would need to go through Seiler Instrument Company for this purchase. They typically provide training for a day to the purchaser of new equipment.

Please let me know if you wish to move forward with any of these. I am available to discuss other options if you prefer....
