ORDINANCE NO. 10-47

AN ORDINANCE CHANGING THE RATE OF THE SIMPLIFIED MUNICIPAL TELECOMMUNICATIONS TAX

WHEREAS, pursuant to Ordinance No. 04-54 adopted on September 14, 2004, the Village set the rate of the Municipal Telecommunications Tax imposed pursuant to Sections 5-25 and 5-30 of the Simplified Municipal Telecommunications Tax Act, 35 ILCS 636/5-1 *et seq.*, at 5.0%;

WHEREAS, the corporate authorities deem it appropriate to increase the rate of the Simplified Municipal Telecommunications Tax by 1%, to 6%;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, AS FOLLOWS:

SECTION 1: The rate of the Simplified Municipal Telecommunications Tax imposed pursuant to the provisions of Sections 5-25 and 5-30 of the Simplified Municipal Telecommunications Tax Act, 35 ILCS 636/5-1 *et seq.*, shall be 6.0%, for all gross charges billed by telecommunications retailers on and after January 1, 2011. The rate shall remain at 5.0% for all gross charges billed by telecommunications retailers through December 31, 2010.


SECTION 2: Revenue received from this tax shall be allocated 80% going to the General Fund and 20% to the Police and Public Works Utility Tax Fund.

SECTION 3 This Ordinance shall be in full force and effect from and after its passage and approval and publication in pamphlet form as required by law, The Clerk is hereby directed to publish this Ordinance in pamphlet form and file a


certified copy of this Ordinance with the Illinois Department of Revenue on or before September 10, 2010.

SECTION 4: The Clerk shall cause Section 1 of this Ordinance to be codified as Section 116.1 of the Village of Chatham Code of Ordinances and Section 2 of this Ordinance to be codified as Section 116.2 of the Village of Chatham Code of Ordinances. The remainder of Chapter 116 is repealed.
