# AN ORDINANCE APPROVING THE FINAL PLAT OF SUBDIVISION OF AVENEL SUBDIVISION, PLAT 1

WHEREAS, on <u>SEPT 2010</u>, the Planning Commission of the Village of Chatham reviewed and recommended approval of Plat 1 of Avenel Subdivision.

WHEREAS, proper security for Plat 1 in an amount approved by the consulting engineer for the Village has been tendered by the Developer of Plat 1 of Avenel Subdivision.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1**: The final plat of subdivision of Avenel Subdivision, Plat 1 and documents thereto attached are hereby approved.

SECTION 2: The Village President is authorized and directed to sign said Plat 1 on behalf of the Village.

SECTION 3: As recommended by the Consulting Engineer for the Village pursuant to a correspondence attached hereto as Exhibit A, surety in the amount of \$67,700 for construction of the public improvements in Avenel Subdivision, Plat 1 is hereby approved. Letter of Credit No. SLCLSTL06306 in that amount issued by US Bank on February 8, 2011, attached as Exhibit B, is approved as surety therefor.

**SECTION 4**: This Ordinance is effective immediately.



#### Dear Meredith,

Yesterday I did a "Final Inspection" of the infrastructure for Avenel. There were minor items that were noted that need to be completed, they are:

#### Sanitary Sewers:

Manhole Rt. of 10+70, Structure A, reset frame and adjust height. Manhole Rt. of 18+81, Structure D, replace frame.

### Water System:

Valve Lt. of 13+56, off the 18" line, adjust valve box height, about 12" to high. Valve Lt. of 13+56, off of 6" line, replace and reset 2 valve boxes, both have been hit, adjust height off back of curb.

Valve Lt. of 14+42, locate, could not find.

#### Storm Sewer System:

Structure #3, Lt. of 10+95, stub out of inlet a 6" PVC line under sidewalk for future sump pump connections. 6" line needs to go across lots 2,3, & 4.

Structure #4, Rt. of 10+95, remove dirt.

Structure #5, Rt. of 10+95, reset and reseal frame, remove dirt.

Structure # 10, Lt. of 17+03, stub out of inlet a 6" PVC line for future sump pump connections. 6" line needs to go across lots 5,6,7,&8.

Structure #12, Rt. of 19+04, seal back of inlet frame, remove dirt.

Structure #13, Rt. of 20+45, need to install grate on 15" P.R.C.F.E.S.

Structure #17, Rt. of 19+05, set frame and open lid.

Structure #18, Rt. of 19+94, riprap needs to be installed.

Paved swale behind Lots 14 to 23 have not been installed.

#### Dirt Work:

Dirt needs to be placed along the east edge of the new concrete path along Gordon Dr. to prevent undermining of the concrete.

Temporary seeding needs to be done.

The sidewalk between Lots 11 and 12 have not been installed. Ordinance requires the sidewalk to be installed when curb & gutter is installed.


