WHEREAS, the bids were opened and the lowest responsible bidder identified as HD Supply for Fixed Pole Mounted Capacitor of \$6,608.00 and Auto Pole Mounted Capacitors of \$30,781.00. Bids for Substation Capacitors were rejected.

On June 20, 2011, the Village opened bids for the substation and pole mounted capacitor banks. The Village received five (5) bids for the project. The bid results were as follows:

The substation capacitor bank bids were vague at best. After receiving more information we have concluded that the low bidder for the substation capacitor bank met the specifications.

Additional information was also received from the low bidder for the pole mounted capacitor banks and we determined that their bid met the specifications.

We recommend awarding the two (2) substation capacitor banks to Controllix Corporation based on the low bid of \$131,642. We also recommend awarding the pole mounted capacitor banks to HD Supply based on the low bid of \$37,389.
