ORDINANCE NO. 11- 49

AN ORDINANCE RELATING TO NO PARKING SIGNS ON PLUMMER BOULEVARD

WHEREAS, Staff has reviewed the appropriate traffic manuals and is recommending the placement of no parking signs on Plummer Boulevard from Peach Tree Drive to Gordan Drive.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: No Parking signs shall be erected on Plummer Boulevard from Peach Tree Drive to Gordan Drive.

SECTION 2 This ordinance shall take effect upon its passage and approval as provided by law.

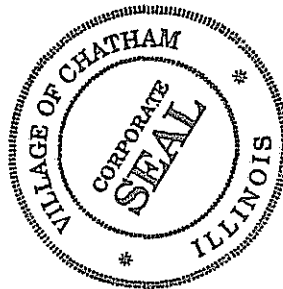

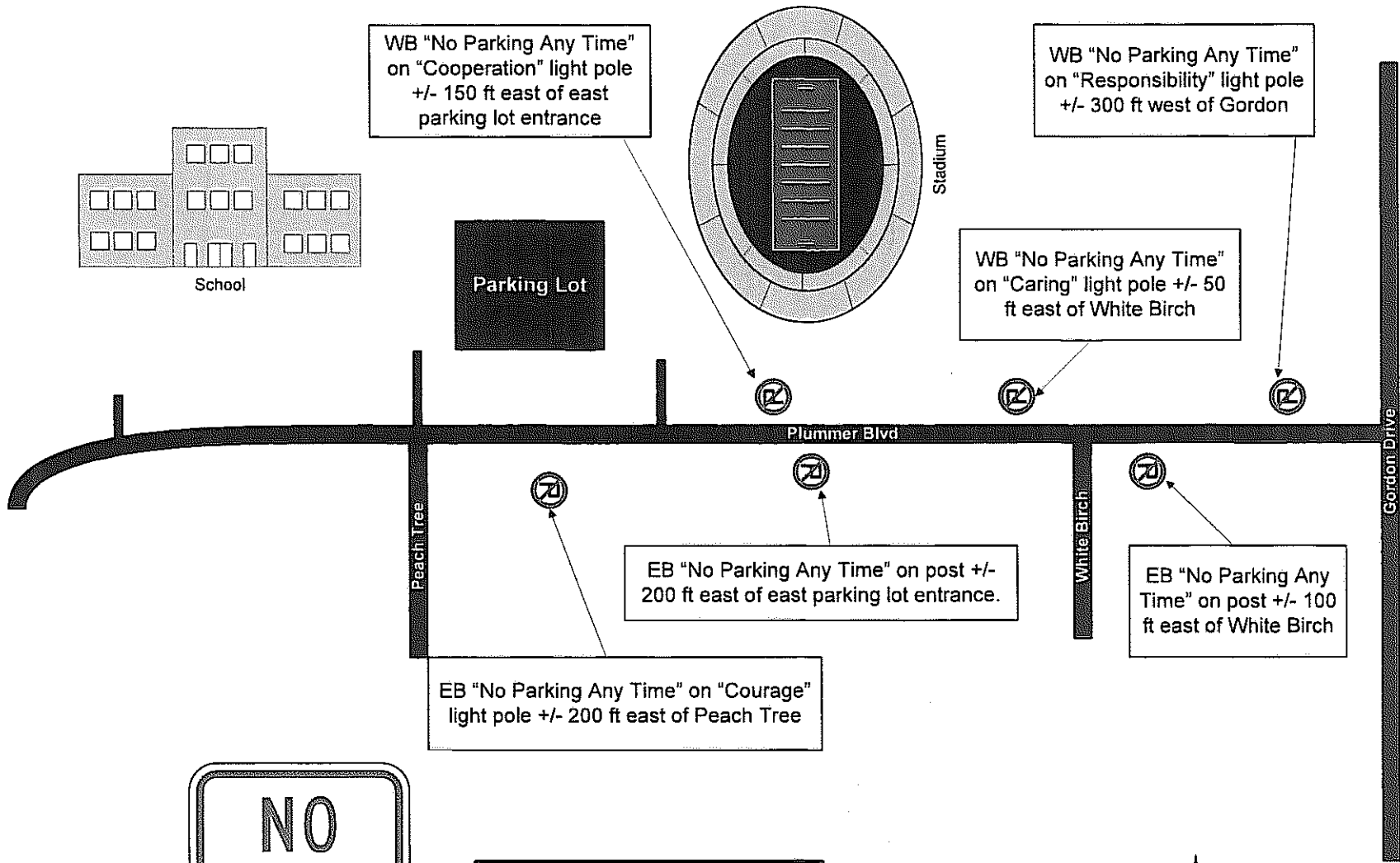
