ORDINANCE NO. 11- 51

AN ORDINANCE PERTAINING TO POLICE SERGEANT SALARIES

WHEREAS, the President and Board of Trustees of the Village of Chatham have determined that it is in the best interest of the Village to maintain a well-trained, professional police force; and

WHEREAS, the Village Board has determined that pay to serve in a supervisory capacity in the Village Police Department must be commensurate with surrounding and competing departments to assist in providing a stable force and planned career path.

WHEREAS, the Administrative Committee is recommending the following salary schedule for Sergeants of the Village of Chatham Police Department.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS AS FOLLOWS:

Section 1: Sergeants of the Village of Chatham Police Department promoted after November 1, 2011 shall be paid their standard base Police Officer salary plus an additional 8% for the balance FY 2012 and all of FY 2013; and base salary plus 10% for FY 2014.

Section 2: This Ordinance shall be in full force and effect upon passage and approval.
