ORDINANCE 12 - 02

AN ORDINANCE IN REFERENCE TO SLIGHTOM EMPLOYMENT

WHEREAS, the Electric Department placed an ad in the local newspaper for a Journeyman Lineman, posted the position on the department bulletin board and the Village's Web Site; and

WHEREAS, the Human Resource Coordinator and the Utilities Manager conducted an extensive series of interviews of potential candidates and prepared recommendations for the Administrative Committee.

WHEREAS, on February 7, 2012 a recommendation was presented to the Administration Committee who is recommending the appointment of Ryan Slightom as the preferred candidate.

BE IT ORDAINED, by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

SECTION 1: Ryan Slightom shall be employed in the Electric Department as a Journeyman Lineman on a full time basis paid per the current union contract. The distribution shall be 100% from the Electric Fund. A probationary period per the current contract shall be observed. Employment start date shall be determined by the Village Manager.


SECTION 2: This Ordinance shall be in full force and effect upon passage and approval.
