

**AN ORDINANCE TERMINATING A CONSULTING AGREEMENT**

*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** That certain Consulting Agreement by and between the Village of Chatham and Timothy S. McAnarney dated October 12, 2004, which was approved pursuant to Ordinance No. 04-62, is hereby terminated, effective 30 days from the date that notice is provided to Mr. McAnarney in accordance with paragraph 4 thereof.

**SECTION 2:** The Village President shall promptly send Mr. McAnarney the 30-day termination notice as provided in paragraph 4 of the Consulting Agreement.

~~**SECTION 3:** The Village President or his designees will enter into negotiations with Mr. McAnarney to provide for the Village consulting services generally in line with the prior Consulting Agreement but with further detail and definition of Mr. McAnarney's responsibilities and enhanced reporting of his activities.~~
