WHEREAS, the Village of Chatham sought and obtained a quote for Roll-off Containers for use during the Village's Annual Cleanup program October 12th and October 19th; and

WHEREAS, the attached **quotes** were opened and the lowest responsible bidder identified; and

WHEREAS, staff has reviewed the quotes and is recommending the acceptance of the quote from Waste Management.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That the quote from Waste Management for \$325 per loaded 30 yard container, and no charge for the 30 yard Scrap Metal Container. Excluded items include but not limited to; tires, liquid paint, yard waste, vehicle batteries, appliances containing freon.

SECTION 2: This Ordinance is effective upon its passage and approval.
