## AN ORDINANCE AMENDING SECTION 35.056 OF THE CHATHAM CODE OF ORDINANCES, PERTAINING TO COMPENSATION FOR NON-BARGAINING UNIT EMPLOYEES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1**: Section 35.056 of the Village Code of Ordinances is deleted in its entirety and replace by the following new Section 35.056:

## § 35.056 ANNUAL SALARY REVIEW FOR NON-BARGAINING UNIT EMPLOYEES.

The salaries of all employees not subject to a collective bargaining agreement shall be established as follows:

(A) The Board shall annually, pursuant to the annual appropriation ordinance, establish the salaries of the Village Manager and the Chief of Police, and shall establish the aggregate of salaries for (a) police officers and (b) all other non-bargaining unit employees.

(B) Within 30 days of adoption of the annual appropriation ordinance, the Village Manager shall, after consultation with the Chief of Police, establish the salaries to be paid to police officers and other non-bargaining unit employees within the aggregate figures established pursuant to Subsection A, and shall report those salaries to the Village Board.

(C) The Village Board may by motion, resolution or ordinance, adjust the salaries as determined by the Village Manager, but unless adjusted by the Village Board, such salaries shall remain effective until adjusted in the following year in accordance with Subsections A and B.

**SECTION 2**: This Ordinance shall be effective upon its passage and approval as required by law. The Clerk shall see to its inclusion in the next update of the Village Code of Ordinances.
