
AN ORDINANCE SCHEDULING REGULAR  
VILLAGE BOARD MEETING DATES  
FOR CALENDAR YEAR 2014


BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That the Regular Village Board Meetings of the Village of Chatham for Calendar  
Year 2014 shall be held at 6:00 PM at the Village Hall, 117 East Mulberry Street, Chatham,  
Illinois on the second (2<sup>nd</sup>) and fourth (4<sup>th</sup>) Tuesday of every month, except in December when it  
shall be only once, on the second Tuesday. Scheduled dates are listed as follows:
