CONSULTING AGREEMENT

THIS AGREEMENT is between the Village of Chatham, Illinois, an Illinois municipal corporation ("Chatham"), and Hero Tameling ("Consultant"), and is effective March 15, 2014.

- 1. Consultant agrees to perform consulting services for the Village, specifically, the preparation of a new Emergency Services and Disaster Agency ("ESDA") Plan for the Village, and shall perform other consulting services relating to ESDA matters as requested from time to time by the Village Manager or by the Chair of the Public Safety Committee of the Village Board.
- 2. For his services, Consultant shall be paid a fee of \$55.00 per hour plus out-of-pocket expenses. Consultant shall from time to time provide the Village with itemized invoices for services rendered, and shall be paid within 30 days of his presentation of each invoice.
- Consultant shall be an independent contractor, and shall not be considered an employee for any purpose related to wages and hours, Illinois Municipal Retirement Fund contributions, workers compensation, unemployment insurance, or any other purpose. Nor shall Consultant hold himself out to third parties as an agent or representative of the Village.
- 4. This Agreement is terminable by either party on 30 days written notice with or without cause.
