#### Ordinance No. 14-22

### AN ORDINANCE PERTAINING TO CONCEALED WEAPONS AND AMENDING THE VILLAGE OF CHATHAM CODE OF ORDINANCES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHA THAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS.

**SECTION 1:** Section 130.01 of the Code of Ordinances of the Village of Chatham is amended to state as follows:

- A. Whoever shall within the village wear or carry concealed about the person any pistol or revolver (without permit), slingshot, metallic knuckles, bowie knife, dirk, razor, or other dangerous or deadly weapon, or whoever shall display any such weapon in a boisterous or threatening manner shall on conviction be fined as provided in Chapter 130.99.
- B. This section shall not be held to apply to any peace officer while in the discharge of the officer's duties, nor any person summoned by the officer to aid in making an arrest or preserving the peace, nor any person permitted by the State of Illinois to carry a concealed weapon.

SECTION 2: This Ordinance is effective upon its passage and approval.

The Clerk shall see to its inclusion in the next published update of the Village Code of Ordinances.
