AN ORDINANCE ZONING HAGAN PROPERTY ON ROUTE 4

WHEREAS, on July 1, 2014 a petition for annexation was filed by David and Helen Hagan on property legally described as 1801 Main Street, more particularly described as Part of the Northeast Quarter of Section 1, Township 14 North, Range 6 West of the Third Principal Meridian, described as follows: Commencing at an iron pipe set over a steel plate in the pavement marking the Northeast corner of the aforementioned Section 1, thence South 89 degrees 57 minutes 49 seconds West along the Township line a distance of 61.99 feet, thence South 00 degrees 27minutes 25 seconds East a distance of 460.62 feet to a point on the West right of way line of Illinois Route 4, said point being the true point of beginning, thence South 00 degrees 27 minutes 25 seconds East along said right of way line a distance of 200.00 feet, thence South 89 degrees 57 minutes 49 seconds West660.60 feet, thence North 00 degrees 27 minutes 25 seconds West 200.00 feet, thence North 89 degrees 57 minutes 49 seconds East 660.60 feet to the true point of beginning. Said parcel contains 3.03 acres, more or less, situated in Sangamon County, Illinois with a Tax Identification Number of 28-01-0 200-017 within the corporate limits of the Village of Chatham, Illinois

WHEREAS, the Owner has requested, and the Village of Chatham Plan Commission has recommended initial zoning of the Property as B-2;

WHEREAS, pursuant to notice duly published in a newspaper of general circulation within the Village, the necessary public hearing has been conducted by the Chatham Plan Commission with respect to the requested zoning.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: The findings in the preamble hereto are hereby adopted.

SECTION 2: Pursuant to the Village's zoning authority under Section 11-15.1-2 of the Illinois Municipal Code the Property shall have B-2 zoning.

SECTION 3: This Ordinance is effective upon its passage and approval.
