AN ORDINANCE APPROVING THE PURCHASE OF POLICE VEHICLES

**WHEREAS**, the State of Illinois sought and obtained bids for various vehicles for model year 2015; and

**WHEREAS**, the Village appropriated sufficient funds in the annual Appropriation Ordinance to purchase two of the vehicles bid.

**NOW, THEREFORE, BE IT ORDAINED** BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

**SECTION 1:** The State of Illinois Joint Purchase Contract #4017160, 2015 Police Pursuit Vehicle, with the lowest bid of \$25,820.00 from Morrow Brothers Ford Inc. is hereby approved for two Utility Police Interceptor vehicles with Police Package for a total cost of \$51,640.
