ORDINANCE NO. 15- 37

**AN ORDINANCE CHANGING THE NAME OF VILLAGE SQUARE TO VETERANS MEMORIAL SQUARE**

**WHEREAS**, the Village of Chatham, Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village of Chatham (hereinafter, the “Village”), is an Illinois municipal corporation; and

**WHEREAS**, the Village was gifted the land as described as follows to be used as green space; and

**WHEREAS**, the aforementioned land is known as Village Square; and

**WHEREAS**, the Corporate Authorities of the Village believe it is in the best interest of the Village to increase rename Village Square; and,

**WHEREAS**, the Corporate Authorities of the Village believe it is in the best interest of the Village to call the land “Veterans Memorial Square.”

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** Renaming of Land. The land known as Village Square shall henceforth be known as “Veterans Memorial Square.”

**Section 3.** Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to

the greatest extent permitted by law.

**Section 4. Repeal and Savings Clause.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.


**Section 5. Effectiveness.** This ordinance shall be in full force and effect from and after passage, approval and publication in pamphlet form as provided by law and the penalty provisions therein shall be effective and commence 10 days after this Ordinance is printed in book or pamphlet form and published by the authority of the corporate authorities.
