ORDINANCE NO. 15- 40

AN ORDINANCE UPDATING THE NUMBER OF OUTSTANDING LICENSES AND INCREASING THE NUMBER OF CLASS R1 AND T LIQUOR LICENSES AVAILABLE WITHIN THE VILLAGE LIQUOR CODE

WHEREAS, the Village of Chatham, Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Chatham (hereinafter, the "Village"), is an Illinois municipal corporation; and

WHEREAS, the Illinois Liquor Control Act of 1934, 235 ILCS 5/4-1, sets forth the rights of municipalities to govern and restrict the sale of alcoholic liquor within their communities; and

WHEREAS, Section 4-2 of the Act provides that the Village has the authority to determine the number, kind and classification of licenses for sale at retail of alcoholic liquor, not inconsistent with the Act, and the amount of local licensee fees to be paid for the various kinds of licenses to be issued; and

WHEREAS, Section 4-2 of the Act provides that the Village has the authority to establish such further regulations and restrictions upon the issuance of a local license not inconsistent with the law as the public good and convenience may require; and

WHEREAS, the Village Board previously has limited the number of various liquor license classifications; and

WHEREAS, the Corporate Authorities of the Village believe it is in the best interest of the Village to update the number of outstanding licenses stated in the ordinance to accurately reflect the number of outstanding licenses, and

WHEREAS, the Corporate Authorities of the Village believe it is in the best interest of the Village to increase the number of Class R1 licenses; and,

WHEREAS, the Corporate Authorities of the Village believe it is in the best interest of the Village to increase the number of T licenses.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Amendment to Village Code - Updating the number of outstanding licenses. Section 111.17 of the Village Code shall be amended by increasing the number of Class R1 licenses available by one.

Section 3. Amendment to Village Code - Number of Class R1 Licenses. Section 111.17 of the Village Code shall be amended by increasing the number of Class R1 licenses available by one.

Section 4. Amendment to Village Code - Number of Class R1 Licenses. Section 111.17 of the Village Code shall be amended as follows (the number of outstanding licenses includes the additional R1 license and T licenses generated by this Ordinance:

(L) The number of licenses issued by the village shall be as follows:

- (1) There may be one Class B license;
- (2) There may be five Class C licenses;
- (3) There may be one Class G license;
- (4) There may be two Class N licenses;
- (5) There may be ~~three~~ two Class P licenses;
- (6) There may be one Class LP license;
- (7) There may be two Class R-1 licenses;
- (8) There may be two Class R-2 licenses;
- (9) There may be one Class RE license;
- (10) There may be ~~one~~ zero Class SE license outstanding at any time;
- (11) There may be ~~three~~ four Class T licenses.

Section 5. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 6. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.



This ordinance shall be in full force and effect from and after passage, approval and publication in pamphlet form as provided by law and the penalty provisions therein shall be effective and commence 10 days after this Ordinance is printed in book or pamphlet form and published by the authority of the corporate authorities.
