ORDINANCE NO. 15- 51

**AN ORDINANCE APPROVING ILLINOIS COUNTIES RISK MANAGEMENT TRUST INSURANCE PROGRAM PROPOSAL FOR THE VILLAGE OF CHATHAM**

**WHEREAS**, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

**WHEREAS**, in October, 2015, the Village sought proposals for its insurance coverage for December 2015 through December 2016; and,

**WHEREAS**, the Village Board of Trustees has determined it to be in the best interest of the Village to accept Illinois Counties Risk Management Trust Insurance Program Proposal for December 1, 2015 through December 1, 2016.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

**Section 2.** Approval of Purchase. The Village Board of Trustees hereby accepts the proposal of Illinois Counties Risk Management Trust upon the terms and conditions set forth in its proposal quote number 15/16 Chatham for program year December 1, 2015 through December 1, 2016.

**Section 3.** Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

**Section 4.** Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall


affect any rights, action, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this Ordinance.

**Section 5.** Effectiveness. This Ordinance is effective upon its passage and publication. The Clerk shall publish this Ordinance in pamphlet form, and shall see to its inclusion in the next update of the **Village Code of Ordinances.**
