

ORDINANCE NO. 15-53

AN ORDINANCE SETTING THE SALARY FOR THE POSITION OF ADMINISTRATIVE ASSISTANT FOR THE VILLAGE OF CHATHAM

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, Section 31.56(D) of the Village Code of Ordinances provides that the compensation of the Administrative Assistant shall be fixed by ordinance from time to time.

WHEREAS, the President and Board of Trustees of the Village have determined it to be in the best interest of the Village to set the salary of position of Administrative Assistant.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

- **Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.
- Section 2. <u>Salary Range for Administrative Assistant.</u> Pursuant to Title III, Chapter 31, Section 31.56(D) of the Village of Chatham Code of Ordinances the salary range Administrative Assistant shall be between Forty Thousand Dollars (\$40,000) and Sixty Thousand Dollars (\$60,000) per year and determined by all relevant factors.
- Section 3. <u>Current Salary of Administrative Assistant</u>. The current salary of the Administrative Assistant shall be set at Fifty-Five Thousand Dollars (\$55,000) per year, and as may later be amended by ordinance.
- **Section 4.** <u>Severability</u>. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

Section 5. Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, action, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this Ordinance.

Section 6. <u>Effectiveness</u>. This Ordinance is effective upon the first payroll cycle in January, 2016. The Clerk shall publish this Ordinance in pamphlet form, and shall see to its inclusion in the next update of the Village Code of Ordinances.
