# AN ORDINANCE NAMING THE VILLAGE OF CHATHAM'S BASEBALL SOUTH PARK DIAMOND #4 "BOB ERICKSON FIELD"

WHEREAS, the Village of Chatham (hereinafter "Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village owns and operates South Park Diamond #4 as a baseball field within the Village; and

WHEREAS, Charles "Bob" Erickson a retired Village of Chatham employee; and

WHEREAS, through his dedication, commitment, and integrity to his position, Charles "Bob" Erickson made many valuable contributions to the community; and

WHEREAS, because of Charles "Bob" Erickson's diligent and faithful efforts in building and maintaining quality public parks and athletic fields, the community has greatly benefited; and

WHEREAS, the Corporate Authorities of the Village believe it is in the best interest of the Village to officially name South Park Diamond #4 as Bob Erickson Field.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

- **Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.
- Section 2. <u>Naming of Baseball Field</u>. The Village Board hereby officially names South Park Diamond #4 as Bob Erickson Field and directs staff to make any necessary signage changes to reflect the new name.
  - Section 3. Severability. In the event a court of competent jurisdiction finds this

ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

**Section 4.** Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

**Section 5**. <u>Effective Date</u>. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
