## ORDINANCE NO. 16-

## A RESOLUTION APPROVING UNION CONTRACTORS MIDWEST'S BID FOR CMT JOB #16046-01-08, LOCAL ROAD IMPROVEMENTS TO MAGNOLIA DRIVE, MARBLESTONE DRIVE, AND WALNUT STREET

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village solicited bids for an improvement to including milling, pavement removal, granular subbase, underdrains, PCC pavement, and HMA surface designated as CMT Job #16046-01-08; and,

WHEREAS, the Village opened said bids on Wednesday, August 31, 2016, at 2:00 p.m.; and,

WHEREAS, there were three bids and United Contractors Midwest submitted the low bid of \$113,126.67, which is below the Village Engineer's Estimate (\$152,773.00) and the Motor Fuel Tax funds appropriated for the project (\$156,500).

WHEREAS, the Village Board of Trustees has determined it to be in the best interest of the Village to award the Contract (BLR12320) to United Contractors Midwest and to execute said Contract (BLR12320) (Exhibit A) and Contract Bond (BLR 12321) (Exhibit B).

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

- **Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.
- **Section 2.** Awarding of Contract. The Village Board of Trustees hereby awards the bid on CMT Job #16046-01-08 to United Contractors Midwest for \$113,126.67 and approves Contract 12320 and Contract Bond 12321.

Section 3. Execution of Contract and Contract Bond. The Village Board of Trustee hereby authorizes the Village President and Clerk to execute Contract BLR 12320 and Contract Bond 12321.

**Section 4.** Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

Section 5. Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, action, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this Ordinance.

Section 6. <u>Effectiveness</u>. This Ordinance is effective upon its passage and publication. The Clerk shall publish this Ordinance in pamphlet form, and shall see to its inclusion in the next update of the Village Code of Ordinances.
