### ORDINANCE NO. 16- 50

## AN ORDINANCE APPROVING THE LEASE OF A MOUNTED COMBINATION SEWER CLEANER VAC TRUCK FROM COE EQUIPMENT, INC.

WHEREAS, the Village of Chatham ("Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/11-61-3, provides the Corporate Authorities of the Village with the power to purchase or lease personal property for public purposes; and

WHEREAS, on July 28, 2016, the Village advertised for sealed bids for a mounted combination sewer cleaner VAC truck ("Truck"); and

**WHEREAS,** one bid was received and on August 8, 2016, that bid was opened, with Coe Equipment, Inc. bidding \$513,150.00, as well as a trade-in credit of \$49,000 and a turnkey leasing option of \$68,538.29 per year for five years; and

WHEREAS, Village staff recommends the turnkey leasing option from Coe Equipment, Inc. be accepted and the Village Manager authorized to enter into the lease for the Truck.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** Approval of Bid. The Board of Trustees of the Village hereby accept the bid of Coe Equipment, Inc., and specifically the turnkey lease option in the amount of \$68,538.20 per year for five years and authorizes the Village Manager to execute any necessary documents to effectuate said lease.

**Section 3**. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

**Section 4.** Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

**Section 5**. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
