# ORDINANCE NO. 16- 6/

### AN ORDINANCE AMENDING ORDINANCE 15-49 TO ALLOCATE ADDITIONAL FUNDS TO THE GOLDENROD DRIVE PROJECT UTILIZING TAX INCREMENT FINANCING REDEVELOPMENT FUNDS

WHEREAS, the Village of Chatham ("Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village previously adopted Ordinance No. 92-47, approving the Village downtown tax increment redevelopment plan, designating the downtown tax increment project area, adopting tax increment financing, and establishing procedures with respect to the downtown tax increment financing area and plan ("Redevelopment Project"); and

WHEREAS, the Village passed Resolution 09-13estimating and designating \$1,400,000 for the Goldenrod Drive/South Main Street Project.

WHEREAS, the Village previously adopted Ordinance 15-49 allocating \$500,000 for the "Goldenrod Drive Project"; and,

WHEREAS, the Illinois Department of Transportation originally estimated the total cost of the project to be \$500,000; and,

WHEREAS, the Village received invoices from the Illinois Department of Transportation totaling \$520,908.02 for the Goldenrod Drive Project.

WHEREAS, the Village Board believes it to be in the best interest of the Village to allocate additional funds to the Goldenrod Drive Project utilizing Tax Increment Financing Redevelopment funds.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

**Section 1.** <u>Recitals</u>. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** <u>Allocation of Funds</u>. Section 2 Ordinance 15-49 is hereby amended so that Redevelopment Project funds, to the extent available, will be provided to the *Goldenrod Drive Project*, as generally set forth in the attached Exhibit A not to exceed \$520,908.02. This represents an additional allocation of \$20,908.02 over the original allocation for the *Goldenrod Drive Project* in Ordinance 15-49.

**Section 3**. <u>Severability</u>. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. <u>Repeal and Savings Clause</u>. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. <u>Effective Date</u>. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
