ORDINANCE NO. 17-06

**AN ORDINANCE AUTHORIZING THE PURCHASE OF LEAF BAGS FOR THE 2017  
SPRING AND FALL VILLAGE CLEANUP**

**WHEREAS**, the Village of Chatham, Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village issued a request for bids for leaf bags for the Village's 2017 Leaf Collection Program; and

**WHEREAS**, the Village received three bids, including from Ace Hardware at .32 per bag, Lowe's at .32 per bag, and Farm & House at .358 per bag; and

**WHEREAS**, although there were two low bids, Ace Hardware is located directly within the Village and its bid is therefore recommended based on its convenience, location and price.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** Authority to Contract with Ace Hardware. The Village Manager is authorized to execute any and all necessary documents to effectuate the purchase of leaf bags from Ace Hardware, at a total approximate cost of \$14,080, for the Village's 2017 Leaf Collection Program.

**Section 3.** Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, action, or causes of action which shall have accrued to

the Village of Chatham prior to the effective date of this Ordinance.


**Section 4. Severability.** In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

**Section 5. Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
