ORDINANCE NO. 17-

AN ORDINANCE AMENDING THE VILLAGE CODE ESTABLISHING TWO REGULAR VILLAGE BOARD MEETINGS PER MONTH AND THE TIME FOR THE COMMITTEE OF THE WHOLE MEETINGS

WHEREAS, the Village of Chatham (“Village”), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village Board previously established a Committee of the Whole for the purpose of discussing non-action items; and

WHEREAS, the Committee of the Whole had been set to meet on the second Tuesday of every month; and

WHEREAS, to create efficiencies, the Village Board desires to call two regular Village Board meetings each month and a separate Committee of the Whole meeting after the first regular board meeting of the month; and

WHEREAS, the Village Board desires to amend Chapters 30 to establish the new meeting procedures.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Amendment. Title III, Section 30.01 shall be deleted in its entirety and replaced as follows:

§ 30.01 REGULAR MEETINGS.

~~The regular meeting of the Committee of the Whole shall be held on the second Tuesday of each month beginning at 6:30 p.m., at which time the only action item~~

~~for formal approval shall be the approval of bills.~~ There shall be two regular meetings of the Village Board as set forth in this section and one Committee of the Whole Meeting. The regular meetings of the Board of Trustees shall be held on the second and fourth Tuesday of each month beginning at 6:00 p.m. The Committee of the Whole Meeting shall be held each month on the second Tuesday of the month, following the regular Village Board meeting, scheduled to start at 6:30 p.m. (or immediately following the regular Village Board meeting if it has not adjourned prior to 6:30 p.m.). Public notice shall be given as provided by statute. If a meeting date should fall on a legal holiday or if there is no quorum present, the meeting shall be held on the next secular day.

Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
