## AN ORDINANCE AUTHORIZING THE PURCHASE OF POLICE MOBILE VIDEO EQUIPMENT, SOFTWARE & MAINTENANCE FROM TKK ELECTRONICS, INC.

WHEREAS, the Village of Chatham ("Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village Police Department has recommended, and the Village Board has budgeted, money for the purchase of mobile video recording equipment and software to be used in Village police vehicles;

WHEREAS, through a joint purchasing agreement with the Wisconsin Department of Transportation and its sealed bids, the Village is able to purchase the equipment, software and maintenance necessary through TKK Electronics, Inc., for a total price of \$46,510.00; and

WHEREAS, as the Village is able to purchase the equipment through a joint purchasing agreement and the equipment was subject to a bidding process, the Village Board requires no other bidding in this situation; and

WHEREAS, the corporate authorities of the Village find it in the best interests of the Village to purchase the equipment, software and maintenance necessary through TKK Electronics, Inc. as set forth herein,.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

- **Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.
- **Section 2.** <u>Purchase Approval</u>. The Board of Trustees of the Village hereby approve the purchase equipment, software and maintenance for the mobile video equipment from TKK

Electronics, Inc., as set forth in the quote attached hereto as Exhibit A, in the amount of \$46,510.00. The Village President and Village Clerk are authorized to execute any necessary contracts or purchase orders, in a form approved by the Village Attorney, to effectuate this purchase.

**Section 3**. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

**Section 4.** Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

**Section 5**. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
