AN ORDINANCE REPEALING ORDINANCE No. 98-14 and ORDINANCE No. 99-08 WHICH ENGAGED CONTRACTED ASSISTANCE AT THE VILLAGE CEMETERY

WHEREAS, the Village previously engaged the services of Roy Skaggs for limited assistance in maintenance and operation of the Village cemetery; and

WHEREAS, due to implementation by the Village of a GIS system and the availability of current full-time Village staff, additional assistance at the Village cemetery is no longer necessary; and

WHEREAS, the Village Board believes it to be in the best interest of the Village to repeal certain previously adopted ordinances establishing assistance in the maintenance and operation of the Village cemetery.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

SECTION 2: Village Ordinance No. 98-14 and Village Ordinance No. 99-08 are hereby repealed in their entirety. If the provisions of this Ordinance are inconsistent with or in conflict with any previously adopted Ordinance, the provisions and intent of this Ordinance shall prevail.

SECTION 3: This Ordinance is effective upon its passage and approval as provided by law.
