**ORDINANCE NO. 17- 38**

**AN ORDINANCE ESTABLISHING AN HONORARY DESIGNATION FOR THE ROADWAY**

**WHEREAS**, the Village of Chatham (hereinafter “Village”), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, there is an existing road that goes through Community Park that is named Volunteer Drive; and

**WHEREAS**, the Corporate Authorities further wish to make the Volunteer of the Year the honorary designated roadway name and place same under the formal Volunteer Road sign each year, with the honorary designation ending the third weekend of July; and

**WHEREAS**, the Corporate Authorities of the Village believe it is in the best interest of the Village to officially honor a Volunteer of the Year each year by making the volunteer’s name as the honorary designation for the year.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** Honorary Designation of Volunteer Drive. Each year, a sign shall be placed under the Volunteer Drive street sign setting forth an honorary street name designation. This honorary street name designation shall be the name of the individual named as the Volunteer of the Year the third weekend in July. After the individual is named, the honorary sign shall be placed under the Volunteer Drive street sign and remain at said location as an honorary designation until the third weekend of July in the following year.

**Section 3. Severability.** In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.


**Section 4. Repeal and Savings Clause.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

**Section 5. Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
