**AN ORDINANCE AUTHORIZING THE PURCHASE OF A
BUCKET TRUCK**

WHEREAS, the Village of Chatham, Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village advertised for sealed bids of a new 53' articulating telescopic aerial device and two companies provided bids, including Altec Industries, Inc. ("Altec") which bid was \$140,310 and Drake-Scruggs Equipment Inc. ("Drake") which bid was \$137,358; and

WHEREAS, the Village bid documents required a 4-function control handle which was not part of Drake's proposal; and

WHEREAS, the ability to have the 4-function control is a safety issue and necessary to the Village;

WHEREAS, the Village Board hereby declares the bid from Altec Industries to be the lowest responsive bid and authorizes the award of the contract to Altec;

WHEREAS, it will take approximately 300 days for assembly and delivery of the vehicle, but the Village Board desires to approve this ordinance to begin the purchase process; and

WHEREAS, the actual funding for the vehicle will be paid out of the FY 2019 Capital Lease program; and

WHEREAS, the Village Board further finds it in the best interests of the Village to authorize the purchase of the corresponding extended warranties.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Authority to Purchase Vehicle. The Village President is authorized to execute any and all necessary documents to effectuate the purchase of an Altec model AT48M installed on a 2018 Dodge 5500 chassis from Altec Industries, as submitted in its bid, at a total amount \$140,310, along with the two extended warranties, at \$4,947 for the Altec Extended Warranty and \$4,550 for the Dodge Extended Warranty.

Section 3. Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, action, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this Ordinance.

Section 4. Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
