ORDINANCE NO. 17- 43

AN ORDINANCE AUTHORIZING A CONTRACT WITH KINNEY CONTRACTORS, INC. FOR AN MFT CONSTRUCTION PROJECT ON OAKBROOK AVENUE WITHIN THE VILLAGE OF CHATHAM

WHEREAS, the Village of Chatham (“Village”), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village has an MFT project scheduled for the removal and replacement of a portion of Oakbrook Avenue; and

WHEREAS, Kinney Contractors, Inc., was the low bidder for the construction work and bid \$162,669; and

WHEREAS, the work to be performed by Kinney Contractors, Inc., is an MFT project to paid out of MFT funds; and

WHEREAS, the Village’s engineer, CM&T, reviewed all of the bids and recommend awarding the bid to Kinney Contractors, Inc.; and

WHEREAS, the Village Board finds it to be in the best interests of the Village to award the MFT contract for the Oakbrook Avenue project to Kinney Contractors, Inc., in the amount of \$162,669.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Approval of Bids. The Board of Trustees of the Village hereby approve the MFT contract for the Oakbrook Avenue construction project with Kinney Contractors, Inc.,

in the amount of \$162,669. The Village Manager is authorized to execute any necessary documents to effectuate the constructs.

Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.


Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
