ORDINANCE NO. 18-49

AN ORDINANCE AUTHORIZING THE PURCHASE OF ELECTRIC DISTRIBUTION MATERIAL

WHEREAS, the Village of Chatham ("Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, on July 26, 2018, the Village advertised for sealed bids for electric distribution material; and

WHEREAS, three bids were received, including bids from Fletcher, Anixter and BESCO; and

WHEREAS, Village staff recommends accepting the bids, as outlined on Exhibit A, from Fletcher and Anixter for the various materials; and

WHEREAS, although BESCO submitted the lowest dollar bid for the transformers, said bid did not meet the specifications which required all copper windings, nor did its bid for the four position secondary blocks meet the required specifications and therefore said bids were not the lowest responsive bids for said products.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Approval of Bid. The Board of Trustees of the Village hereby accept the lowest responsive bids from Fletcher and Anixter for the various electric distribution material as outlined on Exhibit A, and authorizes the Village Manager to execute any necessary documents to effectuate said purchases.

Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
