## **ORDINANCE NO. 18-**

## AN ORDINANCE AUTHORIZING A CONTRACT WITH HORIZON BROS. PAINTING CORP. AS THE LOW BIDDER FOR PAINTING OF THE VILLAGE'S WATER TANKS

WHEREAS, the Village of Chatham ("Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village advertised for bids for painting and related work on the Village's water tanks on January 18, 2018, and January 25, 2018; and

WHEREAS, Horizon Bros. Painting Corp. was the low bidder for the project and bid \$1,089,100 to retrofit and paint and an additional \$23,700 as an alternate bid to add and furnish a tank mixer for the elevated tank; and

WHEREAS, the Village's engineer, CM&T, reviewed all of the bids and recommended awarding the bid to Horizon Bros. Painting Corp. as the lowest responsive and responsible bidder; and

WHEREAS, the Village Board finds it to be in the best interests of the Village to award the contract to Horizon Bros. Painting Corp in the amount up to \$1,089,100 to retrofit and paint and authority for the Village Manager to approve the additional \$23,700 alternate bid Item 1 to add and furnish a tank mixer for the elevated tank if deemed necessary.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

**Section 1.** <u>Recitals</u>. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** <u>Approval of Bid</u>. The Board of Trustees of the Village hereby approve the award of the contract to Horizon Bros. Painting Corp in the amount up to \$1,089,100 and authority for the Village Manager to approve the additional \$23,700 alternate bid Item 1 to add and furnish a tank mixer for the elevated tank if deemed necessary. The Village Manager is authorized to execute any necessary documents to effectuate the contract.

**Section 3**. <u>Severability</u>. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. <u>Repeal and Savings Clause</u>. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
