ORDINANCE NO. 18-50

AN ORDINANCE AUTHORIZING AWARDING A BID TO ILLINOIS VALLEY PAVING FOR THE NORTH PARK AVENUE ROADWAY IMPROVEMENTS

WHEREAS, the Village of Chatham ("Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village recently solicited bids for roadway improvements from Walnut Street to Plummer Boulevard, known as the North Park Avenue Roadway Improvements; and

WHEREAS, four bids were received and Illinois Valley Paving, a division of United Contractors Midwest, Inc., submitted the lowest bid in the amount of \$548,533.11; and

WHEREAS, the Village's engineer, CM&T, reviewed the bids, finds the bid from Illinois Valley Paving to be the lowest responsive bidder and recommend awarding the bid to Illinois Valley Paving; and

WHEREAS, the Village Board finds it to be in the best interests of the Village to proceed with the project and award the bid to Illinois Valley Paving.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

Section 1. <u>Recitals</u>. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. <u>Approval of Bid</u>. The Board of Trustees of the Village hereby approve the bid from Illinois Valley Paving and hereby authorize the Village Manager to execute any necessary documents to effectuate the award to Illinois Valley Paving in an amount not to exceed \$548,533.11.

Section 3. <u>Severability</u>. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. <u>Repeal and Savings Clause</u>. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. <u>Effective Date</u>. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
