### AN ORDINANCE LOWERING THE LETTER OF CREDIT AMOUNT FOR CARDINAL RIDGE FIRST AND SECOND ADDITIONS

WHEREAS, the Village of Chatham, Sangamon County, Illinois ("Village") is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution ("Constitution") and the laws of the State of Illinois, including particularly the Illinois Municipal Code (the "Municipal Code"), and all laws amendatory thereof and supplementary thereto (Chapter 65, Act 5, Illinois Compiled Statutes (1996)); and

WHEREAS, the Village previously required a letter of credit in the amount of \$170,000 for the remaining work in the First and Second Additions of Cardinal Ridge; and

WHEREAS, a reduction in the letter of credit has been requested based on the public infrastructure that has been completed and accepted by the Village; and

WHEREAS, the outstanding items for completion within the First and Second Additions of Cardinal Ridge include: (1) 4" PCC sidewalk installation; (2) detectable warning installation; and (3) Class 2 seeding in the right-of-way; and

WHEREAS, the remaining work equals approximately \$58,584.45, and the Village Engineer has therefore recommended lowering the letter of credit to \$74,000.00 (125% of the estimated amount) as set forth in the engineer's correspondence; and

WHEREAS, the corporate authorities of the Village of Chatham believe it is in the best interests of the Village to lower the letter of credit as recommended by the Village's engineers.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1:** The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**SECTION 2:** The letter of credit for First and Second Additions of Cardinal Ridge shall be reduced to and set at \$74,000.00 as provided for in the written recommendation by the Village Engineer.


SECTION 3: This Ordinance is effective upon its passage and approval as provided by law. PASSED this \3 day of \Novembel( .2018.

Village of Chatham Letter of Credit Reduction

Pat,

CMT was asked by the developer's engineer to review a request for the reduction of the Letter of Credit for the First, Second and Third Additions of Cardinal Ridge. Currently the Letter of Credit stands at \$170,000 which was established to cover all the public improvements for the First and Second Additions, which consisted of sidewalk, sidewalk ramps and seeding within the right of way. In addition, the final paving and curb and gutter for the Garvey Lane cul-de-sac was included for the Third Addition.

The Garvey Lane roadway improvements have been completed and the developer is requesting that the Letter of Credit be reduced to \$74,000 cover the remainder of the sidewalk work and restoration within the public right of way for the entire development.

CMT has reviewed this proposal and concurs with the scope of the outstanding construction items along with the unit prices to perform these items and recommends a reduction in the Letter of Credit from \$170,000 to \$74,000 for sidewalk, sidewalk ramp and restoration within the First, Second and Third Additions of Cardinal Ridge.
