## ORDINANCE NO. 19- 20

## AN ORDINANCE NAMING THE BASEBALL FIELD CONCESSION STAND IN THE VILLAGE OF CHATHAM'S COMMUNITY PARK "TED KOESTER PAVILION"

WHEREAS, the Village of Chatham (hereinafter "Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village owns and operates a concession stand near the baseball fields in Chatham Community Park within the Village; and

WHEREAS, Ted Koester is a long-time volunteer in the Village of Chatham Community with Chatham Baseball, Inc. (now Chatham Baseball and Softball, Inc.) and the Chatham Jaycees; and

WHEREAS, through his dedication, commitment, and many volunteer hours in the Community, Ted Koester made many valuable contributions to Chatham to support the development of youth athletes and the design, construction, and maintenance of facilities in Chatham's park system; and

WHEREAS, because of Ted Koester's diligent and faithful volunteer hours, the community has greatly benefited; and

WHEREAS, the Corporate Authorities of the Village, join with Chatham Baseball and Softball, Inc. and the Chatham Jaycees to take this opportunity to recognize the selfless dedication of Ted Koester to our parks and our youth by officially naming the concession stand at the baseball fields in Community Park, which he designed and led the construction of, as "Ted Koester Pavilion".

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** Naming of the Concession Stand. The Village Board hereby officially names the Concession Stand near the baseball fields in Community Park as Ted Koester Pavilion and directs staff to make any necessary signage changes to reflect the new name.

**Section 3.** <u>Severability</u>. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

**Section 4.** Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

**Section 5.** Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
