### Ordinance No. 20-\_08

## AN ORDINANCE EXTENDING THE HOURS OF OPERATION FOR CERTAIN HOLDERS OF CLASS "T" LIQUOR LICENSES ON SUNDAY, MARCH 15, 2020

WHEREAS, the Village of Chatham ("Village"), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Illinois Liquor Control Act of 1934, 235 ILCS 5/4-1, sets forth the rights of municipalities to govern and restrict the sale of alcoholic liquor within their communities; and

WHEREAS, Section 4-2 of the Act provides that the Village has the authority to determine the number, kind and classification of licenses for sale at retail of alcoholic liquor, not inconsistent with the Act, and the amount of local licensee fees to be paid for the various kinds of licenses to be issued; and

WHEREAS, Section 4-2 of the Act provides that the Village has the authority to establish such further regulations and restrictions upon the issuance of a local license not inconsistent with the law as the public good and convenience may require; and

WHEREAS, Section 111.22(A)(3) makes it unlawful for the holder of a Class "T" license issued under the Code to sell alcoholic beverages on or before 12:00 p.m. on Sundays; and,

WHEREAS, holders of Class "TG" licenses issued under the Code also are prohibited from selling alcoholic beverages on or before 12:00 p.m. on Sundays; and,

WHEREAS, AJ's Corner, the Tap Room, and Sangamon Brewing Company are all holders of either Class "T" or Class "TG" licenses and all have requested that the hours of operation be extended to allow for sale of alcoholic beverages to begin at 10:00 a.m. on Sunday March 15, 2020; and,

WHEREAS, the Village is holding its annual St. Patrick's Day Parade on Sunday, March 15, 2020, which is the cause for the requests; and,

WHEREAS, the President and Village Board believe it to be in the best interest of the Village to extend the permissible hours of sale of alcoholic beverages for AJ's Corner, the Tap Room, and Sangamon Brewing Company to allow for sales to begin at 10:00 a.m. on Sunday, March 15, 2020.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

**Section 1.** <u>Recitals.</u> The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2: Extension of Hours for Sale of Alcoholic Beverages on Sunday March 15, 2020. On Sunday, March 15, 2020, and only on Sunday March 15, 2020, AJ's Corner, the Tap Room, and Sangamon Brewing Company may begin to sell alcoholic beverages at 10:00 a.m. Sales must cease at 12:00 a.m. on Monday, March 16, 2020.

**Section 3**. <u>Severability</u>. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. <u>Repeal and Savings Clause</u>. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to

the effective date of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
