ORDINANCE NO. 21-43

**AN ORDINANCE APPROVING THE PURCHASE OF A 4x4 TRUCK TO BE USED BY THE WATER DEPARTMENT**

**WHEREAS**, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

**WHEREAS**, the Village requested bids for a 4x4 vehicle with 9’ or 11’ dump body or comparable vehicle; and

**WHEREAS**, the Village approved Ordinance 20-30 approving the purchase of a 4x4 vehicle with 9’ or 11’ dump body or comparable vehicle; and,

**WHEREAS**, because of a shortage of vehicles available due to COVID-19, the Village was unable to purchase the vehicle last year; and,

**WHEREAS**, the Village solicited a new quote for a 4x4 vehicle with 9’ or 11’ dump body or comparable vehicle; and,

**WHEREAS**, the Village intends to accept a quote from Landmark Ford Inc., for the purchase of a 2021 Ford F-350 4x4 with a 9’ dump body; and,

**WHEREAS**, the Village Water Department had budgeted \$50,000.00 for the purchase of this vehicle; and,

**WHEREAS**, the Board of Trustees of the Village believe it is in the best interest of the Village to accept the quote from Landmark Ford Inc. as attached hereto;

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

**Section 2.** Acceptance of Quote. The Village hereby approves the quote from Landmark Ford Inc. in the amount of \$48,788.00 as further described in the attached **Exhibit A**. Any and all quotes and parts thereof not explicitly approved by this Ordinance are hereby rejected. The Village authorizes the Village Manager and/or Village President, or designee of either, to execute any documents necessary to complete the purchases contemplated therein.

**Section 3.** Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

**Section 4.** Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.


**Section 5.** Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
